

### American Rescue Plan (ARP) Responsive Grants- City of Kalamazoo

In partnership with the City of Kalamazoo, the United Way of the Battle Creek and Kalamazoo Region (UWBCKR) and the Kalamazoo Community Foundation are collaborating to administer a portion (\$1 million dollars) of the City of Kalamazoo's Federal American Rescue Plan (ARP) State and Local Fiscal Recovery Funds.

Through this open *ARP Responsive Grants- City of Kalamazoo* process, local nonprofit partners are invited to submit funding requests to support work that addresses the negative impacts of COVID-19, aligns with ARP eligible expenditure categories (detailed on Page 2-3) and the City of Kalamazoo's priorities:

- **Economy**—promoting business development, addressing job loss, and promoting economic health.
- Housing—providing ancillary services to address homelessness and housing instability
- Youth—creating places and supports for young people to thrive.

Additionally, priority will be given to organizations and projects that meet one or more of the following criteria:

- Are located in and/or serve Individuals who live in a Qualified Census Tract (QCT) in the City of Kalamazoo (see QCT map and link to address search function on page 3-4)
- Intended primary beneficiaries are those below 60% AMI for Kalamazoo County per the US Dept of Treasury (see AMI table on page 4)
- At least 25% of intended primary beneficiaries are living below the Federal Poverty Line (see 2021 Federal Poverty Guidelines on Page 4).

#### **Opportunity Overview**

- One year grant term—1/1/2022 to 12/31/2022.
- Minimum grant request (and award) of \$50,000.
- Direct administrative costs can be included in request. No indirect administrative cost can be charged.
- Monthly submission of grant expenditure documentation and quarterly reporting reconciling budget and reporting data required.
- UWBCKR staff liaison will work with funded partners throughout grant term to support success in meeting all grant requirements.

#### **Eligibility Criteria**

- 501c3 Organization (or 501c3 fiscal sponsor)
- Program/project serves residents of the City of Kalamazoo

#### Application Process:

1. Attend a required Information Session:

Option 1: October 7, 3-4:30pm Click to Register

Option 2: October 15, 9-10:30am Click to Register

If a representative cannot attend either option, contact communityimpact@uwbckr.org to discuss alternatives.

2. Complete a Qualification Form on e-CImpact to ensure eligibility and assess organization's financial systems.

This form will be available starting October 15 and must be completed by October 29 at Noon.

3. Complete and Submit Application

Based on Qualification Form, applicants will receive information about the reporting requirements they would have if funded.

Application opens on November 1 and must be completed by November 22 at Noon.

- 4. Receive notification of outcome on December 10.
- 5. If funded, complete the provided Grant Agreement by December 20.
- 6. Funding begins on January 1, 2022.


